4. 5. Castleberry High School will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:

Family Engagement meetings; Extracurricular events; Fine Arts performances; College and Career events, Academic Conferences with Counselors, SBDM, DEIC

6 Castleberry High School will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:

STAAR results and assessment information will be mailed at the end of the school year; IGC letters should the need arise

7. Castleberry High School will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:

8 Castleberry High School will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --

- how to monitor their child's progress, and
- how to work with educators:

9. Castleberry High School will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:

Meet the Teacher, Extracurricular Parent Meetings, College and Career Events, Academic Planning Conferences with Student and Parent

10. Castleberry High School will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by


